

Accessing resources for NAPs

Developing countries may access LDCF/SCCF resources in support of the preparation of their NAP processes:

- consistent with the objectives and principles laid out in 5/CP.17 and GEF/LDCF.SCCF.14/06;
- within the scope defined by the initial guidelines:
 - (i) laying the groundwork and addressing gaps
 - (ii) preparatory elements
 - (iii) implementation strategies
 - (iv) monitoring, reporting and review
- through existing GEF modalities: medium-sized projects, full-sized projects and programmatic approaches

Global support programs

- Assisting Least Developed Countries with countrydriven processes to advance National Adaptation Plans (\$2.19M from LDCF, approved in May 2013)
- Assisting non-LDC Developing Countries with Country-driven Processes to Advance National Adaptation Plans (\$5.09M from SCCF, approved in March 2014)
- Expanding the Ongoing Support to Least Developed Countries with Country-driven Processes to Advance National Adaptation Plans (\$6.95M from LDCF)

Support provided through national and regional projects

- "(a) to reduce vulnerability to the impacts of climate change, by building adaptive capacity and resilience; [and]
- (b) to facilitate the integration of climate change adaptation, in a coherent manner, into relevant new and existing policies, programmes and activities, in particular development planning processes and strategies, within all relevant sectors and at different levels, as appropriate" (decision 5/CP.17).

Samoa: Economy-wide Integration of CCA and DRM/DRR to Reduce Climate Vulnerability of Communities

UNDP, \$13.65M from the LDCF, approved in July 2013

- **stocktaking** of all current and planned climate change adaptation projects, plans, reports and assessments;
- establishing a national climate and disaster risk database that is centralized and accessible to all Ministries;
- integrating medium and long-term climate change risks and opportunities into sector plans; and
- developing concrete recommendations to align the next Strategy for the Development of Samoa (2017-2021) with the draft National Climate Change Adaptation Strategy and recommendations for sector plans

Antigua and Barbuda: Building climate resilience through innovative financing mechanisms for climate change adaptation

UNEP, \$5.58 million from the SCCF, approved in Nov 2013

- Policy briefs and technical guidelines developed for policy makers on adaptation – including cost-effective adaptation interventions focused on ecosystems – funded by innovative financing mechanisms.
- Existing policies and plans revised to promote and facilitate adaptation to climate change by using innovative financing mechanisms

LDCF/SCCF: opportunities to advance NAPs

- (i) Projects under early stages of implementation or different stages of preparation could these projects contribute towards the NAP process?
- (ii) Project and program concepts for NAPA implementation – do these present opportunities for advancing the NAP process?
- (iii) Addressing priority needs through projects and programs dedicated to the preparation of the NAP process – flexibility to with regard to scope, focus and duration

GCF: emerging opportunities

"All developing country parties are eligible to receive resources from the Fund. [...]

The Fund will support developing countries in pursuing project and programmatic approaches in accordance with climate change strategies and plans, such as low-emission development strategies or plans, [NAMAs], [NAPAs], [NAPAs] and other related activities." (Governing Instrument, paras 35-36)

All eligible countries may request readiness support for, inter alia, NDAs or focal points to engage with in-country stakeholders; strategic frameworks for engagement with GCF; to meet accreditation standards of the GCF; the development of initial pipelines of programs and projects.
