#### A. PLANNED ACTIVITIES

- To establish a check-point whereto review and update of data collected and other issues are addressed.
- To equally distribute the number of household per team member for ease of workload.
- To ensure 70 percent coverage is achieved.
- To allocate adequate time for effective implementation of activity during our stay.

#### **B. ACTIVITY PROGRESS TO DATE**

The time-poor activity was executed as planned and data was collected and reviewed at the end of each day. It happened that extra activeness was very indeed required to ensure sufficient accommodation of time for report consolidation and sorting of data properly as the last role prior return to base.

On top of everything, regardless of profuse efforts and time invested, the team had ungrudgingly succeeded and comported with the main visit's goal.

### C. RESULTS ACHIEVED

- Surveyed households and coastal fisheries' interrelationship is indeed common.
- Finfish is predominantly harvested compared to invertebrate species and their absolute substitute a.k.a tinned fish. They are commonly consumed on a weekly/monthly basis.
- Variations in seafood consumption across the island.
- Coastal fisheries' abundance is at the verge of unsustainable whereas their distribution is widely sporadic across the island.

#### D. BENEFICIARY

The household's percentage coverage is roughly 70 percent. This indeed accounts to approximately 248 households visited with around 1000 residents. In terms of gender desegregation, interviewees' figure is virtually around 96 percent men and 2 percent women who are heads of each visited household. Government officials stationed on the island who are visited do have a minimal coverage – roughly 2 percent.

The primary challenge is the number of households in Tebangetua is way less than what is specified in our SPC census software programme which would directly intervene with the survey's coverage.
