# Updates

#### Output 1, Activity 1.3.1

#### MNRE CONDUCT HYDROLOGICAL MODELLING TO GENERATE FLOOD SCENARIOS

The implementation of the MCS Digital New Zealand contract for the supply and installation of sirens has made good progress with the shipment and arrival in Samoa of the first container consisting of pole bases/cages on 1<sup>st</sup> September 2022. The container was unloaded on 16<sup>th</sup> September, 2022, and now stored at the MNRE – Water Resources Division (WRD) at Vailima. The shipment of the container with sirens & cabinets arrived in Samoa on 17<sup>th</sup> September 2022 and unloaded on Friday 30<sup>th</sup> September 2022.

Preparation for two public awareness and consultations with affected residents of the Vaisigano River Catchment Area (VRCA) on implementation of Sirens Installation are underway and scheduled for 5<sup>th</sup> and 6<sup>th</sup> of October 2022 at Maluafou College, Maluafou.





#### Output 1, Activity 1.4.1

#### TRANSLATION OF THE APIA SPATIAL PLAN (ASP) INTO A SIMPLIFIED HANDBOOK

The MWTI in a meeting with Alo Mai Consultancy (AMC) on 29<sup>th</sup> August, 2022, reviewed and discussed the AMC's final revisions to the simplified handbook for the Apia Spatial Plan (ASP) and awareness materials/merchandise which includes ASP bookmarks, t-shirts, pull up banner mockups, badges and video footages of AUA. Minor changes have been made to the handbook infographics before it was finalized within the final week of the contract end September 2022, MWTI are in the process of discussing the printing of the materials/merchandise.





#### Output 2, Activity 2.1.1

REVIEW PROPOSED DESIGNS FOR CHANNELIZATION OF SEGMENTS 2, 3 AND 4 OF THE VAISIGANO RIVER INCLUDING THE IMPACT ON CHANNEL CAPACITY OF THE NEW LELATA BRIDGE AND THE POTENTIAL FOR OPTIMIZING SCHEME DESIGN AND DURABILITY



The MWTI with the support of the GCF-PMU facilitated a follow-up consultation with one of the affected families in Segment 3 on 9<sup>th</sup> September 2022, to address remaining issues to be resolved following consultations with other neighboring affected families on the box culvert. The outcome of the planned consultations together with the family's consent will resolve all issues with the finalization of the Memorandum of Agreement (MoA).

The MWTI and GCF-PMU held meeting with Tinai Gordon & Associate (TGA) on 6<sup>th</sup> September 2022, to negotiate and discuss the relevant revisions to the TGA contract scope and deliverables resulting from required additional work due to compliance with safeguards requirements for Segments 2 and 3 of the riverwalls. Cabinet approved on 13<sup>th</sup> November, 2019, the award of the contract to TGA for the design and supervision services of the riverwall in the VRCA.





#### Output 2, Activity 2.2.5

TRAIN MEMBERS OF LOCAL POPULATION ON THESE ALTERNATIVE INCOME GENERATING ACTIVITIES, AS WELL AS BUSINESS INCUBATION FOR ENTREPRENEURIAL AGRIBUSINESS AND CLIMATE CHANGE AND FLOOD-RELATED OPTIONS

MNRE's implementing partner Civil Society Support Programme (CSSP) facilitated and coordinated a Market Day for grant beneficiaries of the Ecosystem based Enterprise Development Programme (EbAEDP) on 8<sup>th</sup> and 9<sup>th</sup> September 2022, at Malaefatu Reserve. The two days event was not only to support the celebration of the Teuila and 60<sup>th</sup> Independence, but to raise awareness of the EbAEDP and also promote some of the grantees' businesses. The initiative allowed the EbAEDP grantees to promote their businesses which included mixed farming, ornamental gardening, agroforestry, and green paper recycling initiatives that support economic livelihood and environmental sustainability. The stalls displayed and sold a variety of locally made handicrafts, ornamental plants, fruits and vegetables, crops, local dishes/cuisine.















#### Output 2, Activity 2.2.5

Ongoing trainings for technical assistance and support are conducted by Samoa Business Hub (SBH) as MNRE's implementing partner together with collaborating partner Ministry of Agriculture and Fisheries (MAF), for all EbAEDP grant beneficiaries.

#### IMPLEMENTATION OF DRAINAGE UPGRADES

LTA, UNDP, GCF-PMU and STANTEC as the contractor of the activity together with it's local counterpart KCL, conducted a site visit to all priority Drainage Sites on 23<sup>rd</sup> August, 2022, to confirm completion of snag list/defects works. Prior to the joint site visit, GCF-PMU held a meeting with STANTEC, KEW and LTA on 22<sup>rd</sup> August, 2022, to discuss status of the contractors' implementation, contract closing and pending deliverables.
