- Integrated adaptation
- Sustainability
- Development first adaptation
- Resilience

We are taking a strategic approach, seeking the dynamic alignment of:

- policies,
- programmes, and
- projects (activities)

## Integrated adaptation

Occurs at a *policy* level & at a *technical* level:

At the *policy level* collaboration between ministries can be mandated.

At the *technical level* integrated adaptation is achieved by implementing *programmes* provided by multiple ministries, through joint work between:

- a community
- a hub-ministry in collaboration with other ministries
- a bridging organization, e.g. USP/SPREP/SPC
- an implementing agency, e.g. World Bank/UNDP

The joint work develops innovative funding arrangements for *community adaptation planning* and *project* development and implementation.

### Sustainability

A *hub-ministry* emerges, is not fixed and is flexible.

Collaborations between the *hub ministry* and other ministries *co-develop* with:


- •community institutional and human resource capability to be able to;
- •use and implement programmes provided by the said ministries, and to
- •develop and implement community adaptation plans and projects.

Sustainability of adaptation occurs when able to continue to utilize *programmes* to develop *community adaptation plans* and adaptation *projects*.

The *private sector* becomes increasingly important to fund these activities.

#### Development-first adaptation


- The *private sector* operates effectively within *civil society*.
- A danger is that *funding agencies* inhibit the development of *civil society* by replacing the role of the *private sector*.



- In LCDs, private sector development primarily means assisting family entrepreneurship to develop sustainable livelihoods.
- Customary activities and traditional knowledge assist the development.

#### Resilience

- Deprivation leads to confusion & frustration.
- Resilience comes from moderation due to balance brought by community institutional functionality, especially learning processes.



- Resilience comes from development of social capital and civil society.
- NGOs can develop *civil society* if they assist development of *community institutional capacity* and *family entrepreneurship*, grounded in cultural tradition.
